



## **THE BAIRD FAMILY HOSPITAL**

### **2<sup>nd</sup> Floor Wards, Link Bridge and Link Corridors**

### **Phase 1 Consultation and Designs**

#### **Background**

Grampian Hospitals Art Trust (GHAT) is committed to ensuring access to art for all by commissioning professional artists to deliver quality projects within challenging public healthcare settings and undertaking continuous action research within the arts and wellbeing sector. We have created the only commissioning, contemporary arts space to be found in an acute hospital in Britain with unique opening hours for a gallery - 24/7. GHAT strives to highlight culture as a key component of wellbeing and is a sector leader in developing bespoke arts projects for people visiting, working or utilising the services within hospitals and healthcare.

#### **The Baird Family Hospital**

In June 2014, the Scottish Government announced an investment for a new health facility on the Foresterhill Health Campus in Aberdeen. The plans included a new hospital to replace the existing Aberdeen Maternity Hospital, with the inclusion of breast screening, breast surgery and gynaecology services, as well as a separate centre for out-patient and day-patient oncology and haematology services.

Following a public consultation exercise in 2015, it was decided that the new facility would be called **The Baird Family Hospital** in recognition of the contribution made to women's health in the North East and beyond by the Baird family.

The hospital will include all of the services currently provided at Aberdeen Maternity Hospital (AMH) as well as other clinical services which are currently located elsewhere on the Foresterhill site:

- Maternity Services including a Community Maternity Unit
- Gynaecology Services
- Breast Services
- Neonatology Services
- Aberdeen Centre for Reproductive Medicine
- Radiology Services
- Operating Theatres
- Research and Teaching Facilities
- Non-Clinical Support Services

The hospital will be located towards the west of the Royal Aberdeen Children's Hospital (RACH). There will be physical connections from the new hospital to both RACH and to Aberdeen Royal Infirmary (ARI).

### **Key project facts:**

- The hospital will be around 26,000m<sup>2</sup> in size, with over 1,000 rooms.
- The hospital will have physical links into Aberdeen Royal Infirmary and Royal Aberdeen Children's Hospital to allow easy transfer for patients.
- The hospital will open for patients in March 2024.

GHAT have been working with NHS Grampian to deliver the arts and environment programme for both facilities. An Arts and Environment strategy has developed through engagement with the stakeholders with the Aim:

***To create a well-designed, person centred and positive visual environment for patients, staff and visitors.***

### **The Brief:**

The project will be delivered in 2 phases. Phase 1 will be to deliver the consultation and fully costed designs. Phase 2 will be to deliver the manufacture and installation of all artwork.

The Artist(s) awarded Phase 1 of the commission will be expected to deliver Phase 2. The fully costed designs from the Phase 1 Brief will go towards supporting the final fundraising target of the overall commission.

GHAT is seeking applicants who can demonstrate strong visual art and design skills. They will also require a background in consultation methods which include the stakeholders in the design of the work. The role of the artist(s) will be to work with GHAT and NHS Grampian to create artwork for the Baird Family Hospital for the following inside the new facility:

- Corridor spaces for both wards on the 2<sup>nd</sup> Floor
- Link Bridge from The Baird Family Hospital to Aberdeen Royal Infirmary/Royal Aberdeen Children's Hospital
- Link corridor

**All work must be manufactured and installed by December 2023.**

The Artist(s) will work closely with NHSG staff, public representatives and patient groups to:

- integrate artwork into the full environmental design linking architecture, interior design and wayfinding;
- create artwork which will sustain the interest of viewers and that will not readily date and which retains interest on repeated viewing;
- create artwork which is visually interesting, relevant and promotes a positive sense of wellbeing;
- make effective use of links with the organisations and groups in the immediate area.

The project will be managed by the GHAT Senior Manager Projects with support from a dedicated Project Assistant.

**Experience:**

GHAT is looking for someone who is an arts graduate with at least two years' experience.

**Desired skills:**

1. Knowledge of contemporary arts practice at a national and international level.
2. Knowledge of the skills required to deliver a socially engaged participatory project
3. Experience of working in public art projects

**Main tasks for this brief:**

**Phase 1** - The Artist(s) will work with GHAT to prioritise the following tasks.

- Deliver workshops and public consultation sessions with NHS Grampian services, patient groups and funders which will inform the design of the artwork
- Liaise with the Project Manager to ensure all artwork materials and installation is compliant with NHS Grampian Health and Safety and Infection Control policies
- Engage with Interior Design Strategy and the Arts and Environment Strategy
- Produce fully costed designs which will be signed off by NHS Grampian and GHAT

**Phase 2** - The Artist(s) will work with GHAT to prioritise the following tasks.

- Source manufacturers
- Liaise with manufacturers and GHAT Project Manager
- Timetable installation of artwork
- Agreeing and coordinating infrastructure arrangements

**Budget:**

**Phase 1** - The budget will include

- the artists fee for consultation and design
- all travel for site visits and workshops/consultations

The budget for this brief is **£5000 (including VAT)** payable in a pattern to be agreed between GHAT and the artist.

There is a budget of up to £750 for workshop materials and expenses.

**Phase 2** - The budget will include

- the artists fee
- all materials and expenses
- manufacture, fabrication and installation
- Any additional infrastructure costs due to the construction company created by the installation of the artwork

The final fundraising target for this brief is **£20,250 (including VAT)** payable in a pattern to be agreed between GHAT and the artist.
